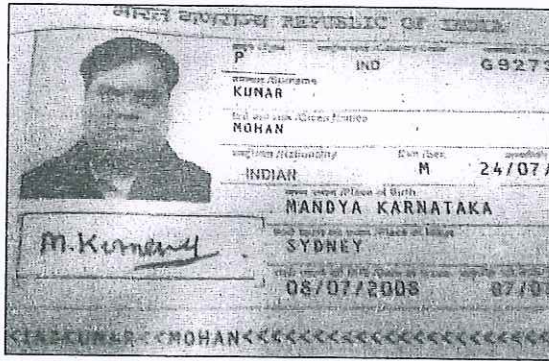

WITH THE trial in the murder of crime journalist Jyotirmoy Dey underway, where Chhota Rajan is shown as wanted, sources said the Mumbai Police will stake claim to the gangster's custody for a fresh chargesheet in the case.

The murder probe is expected to be the first file to be opened to ensure Rajan is taken to court as soon as he is deported. "We will request the Centre to allow the Mumbai Police to take Chhota Rajan's custody," Minister of State (Home) Ram Shinde told media persons on Monday.
