Singer India Limited Familiarization Programme for Independent Directors

1. Preamble:

The Regulation 25 (7) & Regulation 46 (2) (i) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 resp. stipulates that:

- The Company may circulate news and articles related to the industry on a regular basis and may provide specific regulatory updates from time to time; and
- The Company may conduct an introductory familiarization programme / presentation, when a new Independent Director comes on the Board of the Company.

3. Programme and disclosure

Familiarization programme will be conducted "as needed" basis during the year. As and when familiarization programme is conducted, the same will be disclosed on the website of the Company as per Annexure 1.

4. Review of the Programme

The Board will review the familiarization programme of Independent directors and make revisions as may be required.
