Sub.: Update on the Notice issued by Ministry of Consumer Affairs, Food & Public Distribution Government of India for Cancellation of License No. CM/L- 4100049170 of Mechanical Household Zig-Zag Sewing Machine as per IS 15449: Part I: 2004

Dear Sir/ Madam,

This is in continuation to our earlier intimation dated August 08, 2023, wherein we had informed about the suspension of license of our vendor bearing BIS Certification Marks License No. CM/L- 4100049170 ('License') granted for use of the BIS Standard Mark (ISI mark) on Mechanical Household Zig- Zag Sewing Machine as per IS 15449: Part 1: 2004. The said license stands cancelled by the Competent Authority with effect from 08-08-2023 as per the provision of Regulation 11 of the BIS (Conformity Assessment) Regulations, 2018.

Further, in compliance with Regulation 30 of Listing Regulations and relevant circulars/notifications in this regard issued by SEBI, below are the details of the event occurred:
