Pursuant to SEBI Listing Regulations and in compliance with the Notification No. SEBI/LAD-NRO/GN/2023/131 which becomes effective from July 14,2023, issued by the Securities and Exchange Board of India ('SEBI'), we wish to inform you that BIS Certification Marks License No. CM/L- 4100049170 ('License') granted to our Vendor for use of the BIS Standard Mark (ISI mark) on Household Zig-Zag Sewing Machine as per IS 15449: Part 1: 2004 is put under suspension due to discrepancies observed with regard to the operation of the license by authorities. This will effect our ability to import and sell Singer Branded Household Zig-Zag Sewing Machine.
