Pursuant to SEBI Listing Regulations and in compliance with the Notification No. SEBI/LAD-NRO/GN/2023/131 which becomes effective from July 14, 2023, issued by the Securities and Exchange Board of India (‘SEBI’), we wish to inform you that Canteen Store Department, Ministry of Defence has suspended the sale of 8 items because they observed that the required details of manufacturing location/factory address on label/package are not been supplied as per Legal Metrology (Packaged Commodities) Rules, 2011. The products are being supplied without mentioning the details.
