Sub.: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations").

Dear Sir/ Ma'am,

In continuation of our earlier intimation dated July 22, 2025, and pursuant to Regulation 30 read with Schedule III Part A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we, Singer India Limited ("the Company"), informed you earlier that one of the Company's business partners, Central Government Employees Consumer Cooperative Society Limited, commonly known as "Kendriya Bhandar", participated in a tender on the GeM Portal and was selected as L1 for the supply of 2,81,128 Tool Kits for the Tailor trade under the PM Vishwakarma Scheme, awarded by the DC MSME (PMV Division) through NSIC. The Tool Kits include variants of Singer brand sewing machines (Models: Tailor and Universal) along with other allied items.

As previously intimated, the award of the said contract was challenged before the Hon'ble High Court of Delhi; and the matter was subjudice, without any specific order to stop the supplies.

The Hon'ble High Court of Delhi, vide its order dated January 13, 2026, dismissed the writ petition challenging the award. The Court upheld the rejection on the grounds of lack of merit and dismissed the petition. The pending applications were also disposed of accordingly.
